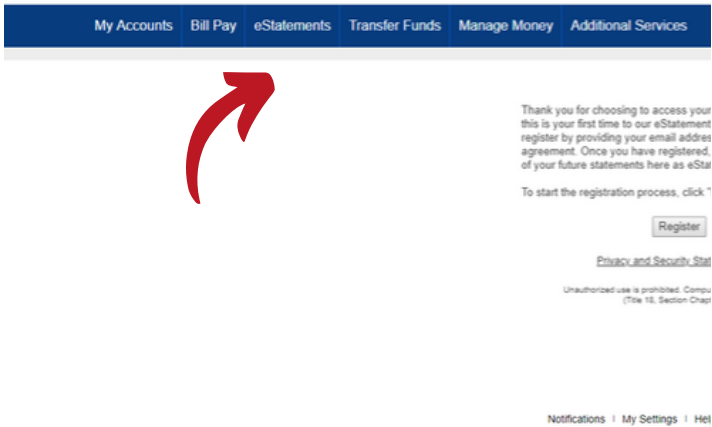


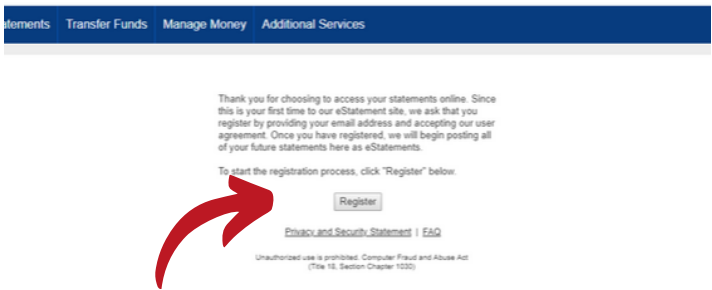
# SIGN UP THROUGH ONLINE BANKING

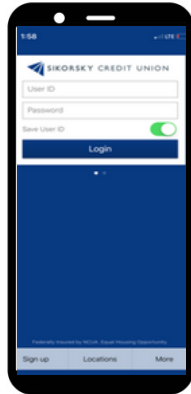

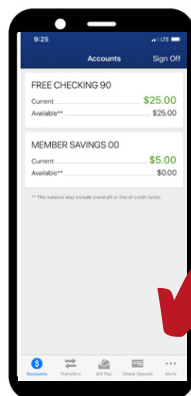

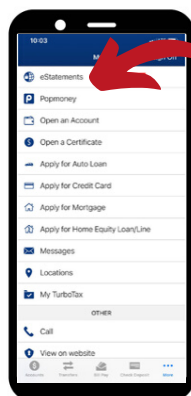
## Step 1:
