

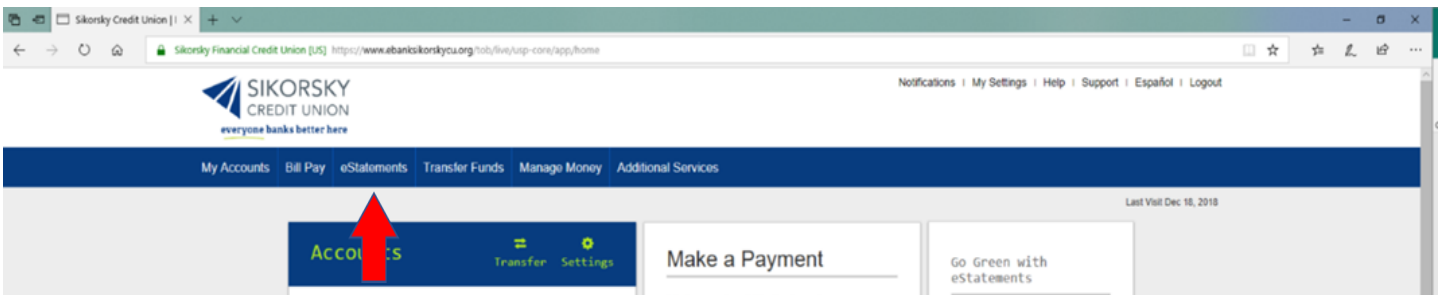
Step by step guide to: eStatements

What are eStatements?

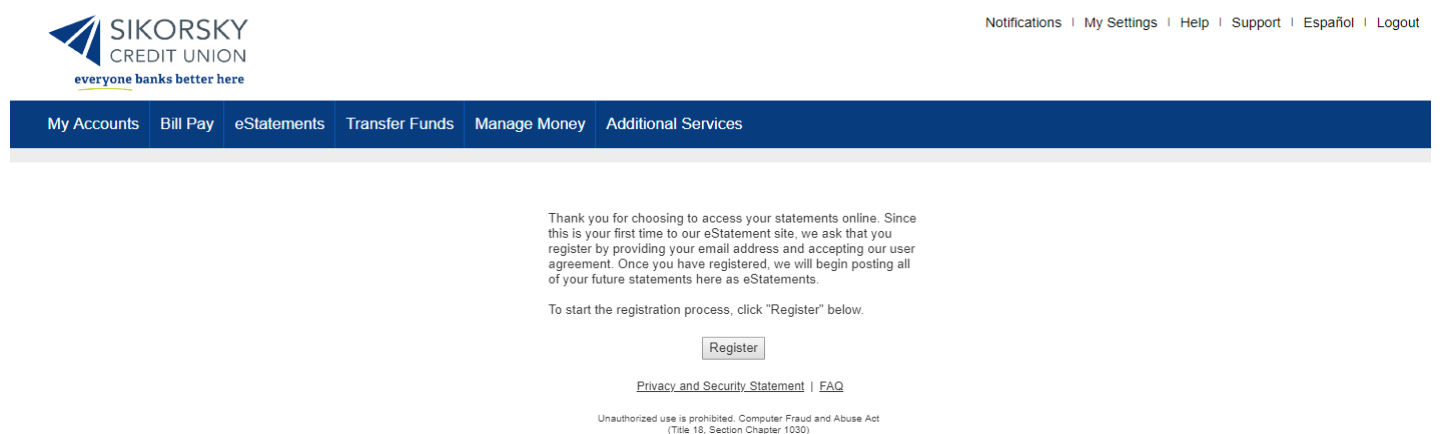
eStatements are electronic copies of your account statements that you can view through the online banking portal. Signing up for eStatements is a secure way to view your statements as soon as they're available from the convenience of your computer or mobile phone.

Signing up for eStatements Online

Once logged into the online banking portal, click on eStatements located in the blue bar underneath the Sikorsky Credit Union logo.



You will be brought to the screen below. Please click on register to continue.



After clicking on register, you will be brought to the screen below. Please fill out your first name, last name, and email address and click "Next".

Sikorsky Credit Union Electronic Statement (eStatement) Consent Agreement

Please read this information carefully. You may print a copy for your records or you may access this disclosure at any time from your eStatement selection page.

This agreement is between Sikorsky Credit Union (hereinafter "we, us, our or the Credit Union"), and each participating member of the Credit Union's eStatement program, together with any person who is authorized by a member to use or access this service (hereinafter referred together as "you, your, or yours").

eStatement Access

Accessing your eStatement confirms your agreement to be bound by all disclosures and agreements and acknowledges your receipt and understanding of this agreement.

By accessing your on-line Periodic Statements you will be able to view your periodic account and transaction activity for your deposit and loan accounts, electronic funds transfer transactions, periodic notice of billing error rights under Federal Regulations Z and E, and Credit Union newsletters and/or statement stuffers, which may contain important legal notices that affect you.

We may also choose to deliver to you electronically other notices that we produce electronically, such as Loan Payment Notices, Maturity Notices, etc.

In order to access your eStatement on-line, you must have an active Online Banking Service established with the Credit Union. Once that is established, you may log on to our Online Banking Service via the Internet, with is <http://www.sikorskycu.org> (called the "Web Site"), click on the Online Banking link and use your account number and PIN to log on. Then click on the "Accounts" menu tab and click "eStatements".

Online Banking and eStatement services have independent and different time out programs. We strongly recommend that you log off from each service when you have completed your work.

The Online Banking Service is normally accessible seven (7) days a week, twenty-four (24) hours a day with the



statements you receive and notify the Credit Union within established time periods if there are any errors on your statement.

Authorization Consent. By agreeing to the terms and conditions of this consent, you represent that you are authorized to enter into this consent for all persons who own or are authorized to access any of your accounts, and that such persons will be bound by the terms of this consent.

Email Communications. You acknowledge and agree that the Internet is considered inherently insecure. Therefore, you agree that we have no liability to your whatsoever for any loss, claim or damages arising or in any way related to our response(s) to any email or other electronic communication that we in good faith believe you have submitted to us. We have no duty to investigate the validity or to verify an email or other electronic communication; and may respond to any e-mail at either the address provided with the communication, the email address in your Membership Account Agreement, or any other application or written communication actually received by us.

Although we have no obligation to do so, we reserve the right to require authentication of emails or electronic communications. The decision to require authentication is at the sole discretion of the Credit Union. We will have no obligation, liability or responsibility to you or any other person or company if we do not act upon or follow any instruction to us if a communication cannot be authenticated to our satisfaction.

Governing Law. This agreement, including the validity of any signatures or consents, any claim, or disputes arising hereunder shall be construed in accordance with and governed by the Laws of the State of Connecticut.

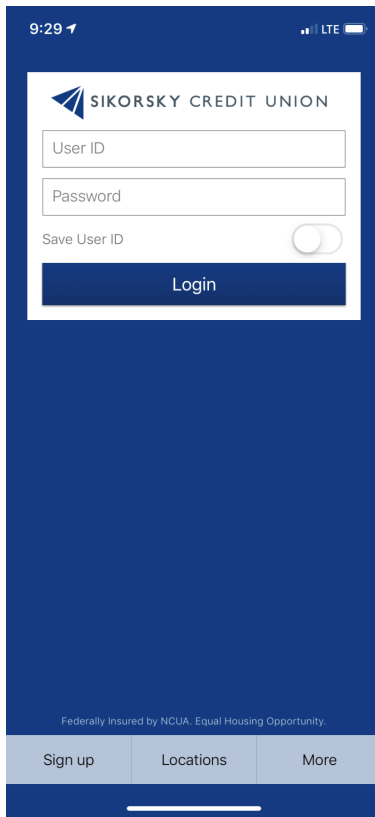

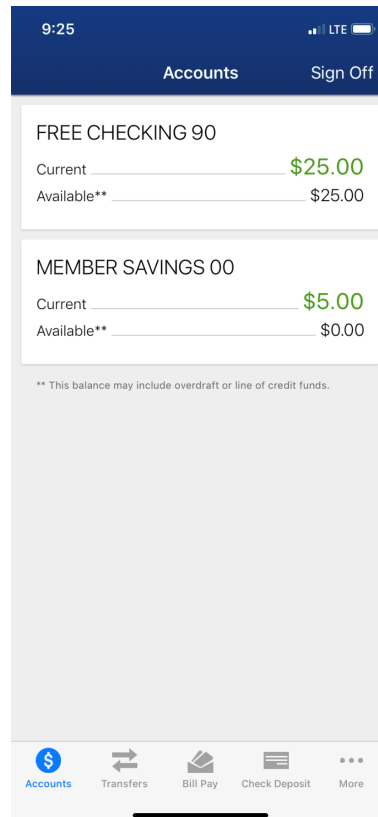

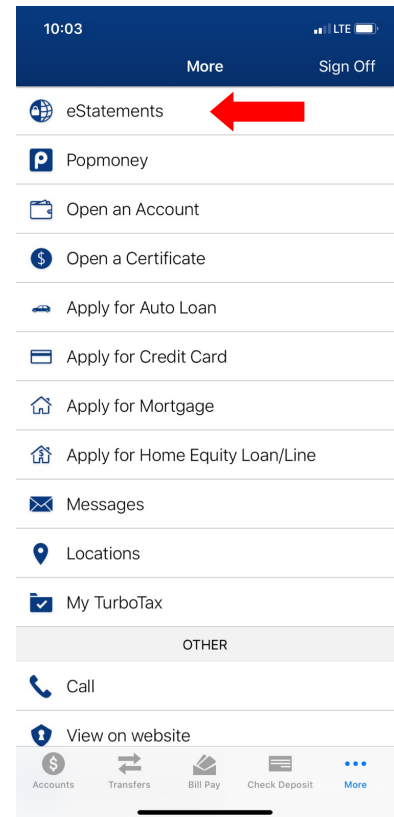
