Promotional Period for Introductory APR - Visa Advantage and Visa Platinum:

The Introductory APR for purchases will apply to transactions posted to your account during the first 180 days following the opening of your account. The Introductory APR for balance transfers will apply to transactions posted to your account during the first 90 days following the opening of your account. Any existing balances on Sikorsky Financial Credit Union, Inc. loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

Other Fees & Disclosures:

Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are one or more days late in making a payment.

Balance Transfer Fee (Finance Charge) - Visa Advantage, Visa Platinum:

2.00% of each balance transfer during the promotional period only.

Cash Advance Fee (Finance Charge):

3.00% of each cash advance.

Returned Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$10.00.

Document Copy Fee:

\$5.00.

Pay-by-Phone Fee:

\$15.00.

Statement Copy Fee:

\$5.00.
