The Introductory APR for balance transfers will apply to transactions posted to your account during the first 90 days following the opening of your account. Any existing balances on Sikorsky Financial Credit Union, Inc. loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

For clarity, you will not be deemed a covered borrower if: (i) you establish your credit card account when you are not a covered borrower; or (ii) you cease to be a covered borrower.

Late Payment Fee:

Balance Transfer Fee (Finance Charge) - Visa Advantage, Visa Platinum:

2.00% of each balance transfer during the promotional period only.

Cash Advance Fee (Finance Charge):

3.00% of each cash advance.

Returned Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less.
