# **Sikorsky Credit Union Gives Back**

Giving back to our communities is important to us! Whether it's a Food Drive at Thanksgiving time or donating money throughout the year, we take pride in providing for those less fortunate in our community.

This year we have donated over 45,000 to non-profit organizations throughout Fairfield, New Haven & Hartford County. Some of these include: The Neighborhood Studios of Fairfield County, Dolly Parton Imagination Library of Stratford and Jamie Hurley Arts Foundation. We also provided a \$3,000 holiday donation to each of our non-profit community partners: McGivney Center, Impact Trumbull, Center for Family Justice, Seymour Pink, Sterling House, Boys & Girls Club of LNV, Danbury Youth Services, Community Action Agency of Western CT and Boys & Girls Club of Milford. To help us celebrate our 75th anniversary, Sikorsky Credit Union also donated 75 boxes of cereal to the Sterling House.

For a 12th year, we co-sponsored the Milford Trick or Trot 5k Run/ Walk in October. The event was a tremendous success, attracting 500 runners and walkers. All proceeds from this event benefit the Beth-El Center in Milford which provides support services to those experiencing homelessness and hunger within the Greater Milford community.



Lastly, we continued partnering with local high schools to promote financial literacy to high school students through Reality Fairs and classroom presentations on various money topics. In addition, we provided \$5,000 in college scholarships to graduating seniors to help with the rising cost of college tuition.


